PROJECT SUMMARY

The goal of our project is to create an international network for knowledge sharing in the field of Social Integration Enterprises. The Network of partners will include towns, municipalities, experts, non-profit institutions as well as educational and research bodies.

The project counts with 11 partners from ten European countries: Slovakia, Hungary, Italy, Romania, Portugal, Latvia, Czech Republic, Serbia, Croatia and Slovenia. The project will be carried out between September 2017 and December 2018 within 6 events that will take place in 6 different countries. There will be a strong dissemination activity during the whole duration of the project. This project is meant to continue afterwards in form of further cooperation of organizations within the European Network for Social Integration Entrepreneurship, which will be established by this project.

In our project we want to include experienced partners in the field of setting up Social Enterprises as well as partners, who wish to enhance the social and economical life quality of their citizens but lack the needed support and know how. We aim to create a platform for exchanging know how, best practice examples and discussing new paths and possibilities in the field of Social Integration Enterprises. In line with our goals, we want to establish a system for educating unemployed citizens and reintegrating them into work life.

The project counts with a dissemination plan that will access a wide range of citizens on international level. We will use print media, social media and internet channels in order to make the results of the project visible and give the possibility for citizens to directly react and interchange their opinions. The project will have its own website, where detailed information about its results will be progressively added and will include a discussion forum for the website visitors. In cooperation with participating organizations, outcomes will be disseminated and distributed via following channels:

PORTUGAL: Portuguese partner will actively participate on dissemination of results and has access to following means: websites of several local, regional and national entities that are able to share and disseminate the project, access to TV, Radio, Newspapers and Online News Channels, access to different portals regarding partners affiliation in different regional, national and European networks.

Further our partner has direct access to Social Media and also a Communication and PR Department handling social media news and events associated with Municipality.

CZECH REPUBLIC: Town of Jirkov will disseminate the results to its citizens via the Municipality web-page of town Jirkov and via the newspaper "Jirkovské Noviny" published monthly on the third Wednesday in month by the Municipality in a circulation of 9500 pieces.

SERBIA, ITALIA, HUNGARY, LATVIA, CROATIA, ROMANIA: The results will be disseminated through communication channels of the participating municipalities (webpages, local newspapers).

To ensure a multiplier effect we will have the support of our partner institutions and towns who successfully collaborate with local governments, universities, high schools, SMEs, local and foreign enterprises, Chambers of Commerce, EU Development centers and Business Associations. We will have the support of Italian organization Calabria Roma covering 140 members of towns and municipalities which will distribute the information about our project. In Slovakia we will collaborate with APUMS - Association of Heads of Municipal Offices in Slovakia which has effective communication channels and are able to address a big number of local citizens as well as other EU citizens through their partner organizations with similar scope. In Romania we can count with the support of Harghita Council which have the channels to distribute the information in regions.

Also we will strategically use the social media tools facebook and twitter, where we will publish the Manual of Best Practice regarding Social Integration Enterprises, so everybody interested can download it. We will also use the international information network Europe Direct to provide information in real-time and actively interact with the citizens answering their individual questions.
